




Multi-sectoral and collaborative approaches to prevent drowning are essential for impactful and informed local interventions

Partnership Approach to Water Safety - PAWS



A multi-agency approach to raising water safety awareness that combines the knowledge and experience of those individuals and organisations in our communities that best understand the risks, and can manage them.



Scotland's Drowning Prevention Strategy

- Reduce accidental drowning deaths in Scotland by 50 per cent by 2026 and reduce risk among the highest-risk populations, groups and communities
- Contribute to the reduction of water-related suicide.



3 Key Stages of PAWS

- Prevention
- Improved Incident Response
- Review



Key Stage 1 - Prevention

- Education
- Social Media
- Engagement



Key Stage 2 – Improved Incident Response

- Inform the public how to safely respond to a water emergency
- Identify local risks and hot spot locations
- Multi-agency exercises



Key Stage 3 – Review

- Drowning and Incident Review (DIR)
- Refocus Prevention measures through lessons learned




Delivering PAWS

Next Steps

- 1. Arrange inaugural meeting with all partners
- 2. Draw up a Terms of Reference
- 3. Complete a full Risk Review of all water risks in Bolton Borough
- 4. Begin a Bolton Community Water Safety Action Plan
- 5. Decide future meeting frequency and activity





On-going Workstreams

- 1. Design "Low Level" Risk Review Process
- 2. Engage local leaders in Water Safety
- 3. Embed Water Safety in school curriculum
- 4. Scope funding to support local WSPs
- 5. Collaborative approach to suicide by drowning
- 6. Improve data collection and sharing
